- (c) To diffuse useful, educational, literary, social, academic, professional and other knowledge.
- (d) to assist students to pursue their academic, professional and other studies by providing scholarships, hostel facilities, supply of food, books and other requirements free of cost or at concessional rates or otherwise and generally to render assistance, financial and/or otherwise.

- (e) To maintain, run and assist in the provisions of mid-day meals, poor feeding and the like and to distribute food, clothing and the like, free of cost or at concessional rates.
- (f) To manage, organise, conduct, maintain and/or finance all forms of educational training, promotional, publication, research and other educational activities.
- (g) To establish, acquire, manage, maintain, support all types of Medical Institutions including Hospitals, Charitable Dispensaries, Ambulance Service, Oxygen Services, Blood Bank. Maternity Homes, Sanitorium and convalescent homes, Asylums and other Institutions for administering medical relief to the poor.
- (h) To impart training to youths in rendering social services.
- (i) To aid, assist, donate or otherwise contribute funds to societies, institutions, trusts and other funds recognised for the purpose of allowing deduction under Section 80(C) of the Income Tax Act, 1961

To start, establish and maintain all types of educational and cultural institutions in the State for the benefits of Telugu Origin students in addition to others and to promote and strive for the development of Telugu Language and Telugu Culture as the trust is a linguistic minority in nature in Karnataka State.

- (k) To carry out all such acts, deeds and things which are incidental to, or necessary for the promotion of the above mentioned objects.

4. BOARD OF TRUSTEES

(c) The Board shall have power to co-opt one or more persons as members of the Board for such period and on such terms as they may deem fit.

(d) A single member may constitute the Board for a period of not exceeding three months and such member shall co-opt one or more members on the Board of Trustees to increase the strength of the Board to the minimum two.

- (g) Smt. SARADAMMA, Author and Trustee of this Trust, shall hold office during her life or till she voluntarily resigns. After Smt. SARADAMMA ceases to be the Chairman, the Board shall have power not only to appoint one among them as the Chairman and fix the terms of appointments, period of office etc., but also to remove such persons from office even prior to the expiry of his or her tenure of office by a resolution passed by a majority of members of the Board.
- (h) Shri J. SRINIVASA REDDY shall be the First Managing Trustee of the Trust and he shall hold office during his life time or till he voluntarily resigns. After Shri J. SRINIVASA REDDY ceases to be the Managing Trustee, the Board, by a majority decision, shall have power not only to appoint one among them as the Managing Trustee and fix the terms of appointment etc., but also remove such person from the office before his or her term of office.
- (i) All the members of the Trust shall belong to persons of Telugu speaking origin as this Trust is meant for the development of Telugu culture in particular and also Bharatiya culture.

5. POWERS OF THE BOARD

With a view to carry out the objects of the Trust herein above mentioned and to manage and administer the Trust funds and without prejudice to the generality of any powers hereby or by law conferred or implied or vested in the Board of Trustees the Board of Trustees shall have the following powers:

- (a) On execution of this deed the trustees shall take charge of the said sum of Rs.10,000/- (Rupees Ten Thousand only) and it will be the corpus of fixed property of the trust and it shall not be disposed of or subjected to any kind of charge for the purpose of meeting the expenses or for carrying out the objects of the trust or for any other purpose unless otherwise resolved unanimously by the Board of Trustees.
- (b) The trustees shall stand possessed of the said amount of corpus and such other properties both movable and immovable as may be acquired from time to time by the trust by purchase, exchange, gift, grant, subscription, endorsement, donation, contribution or in any manner whatsoever, all of which shall be designated as the "the trust properties" of the trust wherein mentioned.
- (c) The trustees shall have power from time to time to increase or decrease the corpus of fixed property of the trust and this corpus shall not be used in contravention of clause (a) hereinabove.
- (d) To apply and use the funds for all or any of the objects of the Trust and/or to accumulate the surplus unapplied portion of income and invest the same, subject to complying with the provisions of the Income Tax Act, 1961, as amended from time to time, relating to accumulation of income and investment thereof.
- (e) To receive any money or other assets in any shape or form as gift or donation and to hold the same as Capital Fund or apply it for furthering the objects.
- (f) The funds of the Trust shall be invested in the manner specified under the provisions of section 13(i)(d) read with section 11(5) of the Income Tax Act, 1961, and the Trustees are empowered to dispose off, alter or vary the investments from time to time and also to realise the investments.

- (g) To compromise, compound, abandon, subject to arbitration or otherwise institute any actions, suits, proceedings, claims or other things whatsoever arising out of administration of the Trust Fund and to enter into, give, execute and do such agreements or composition or arrangements, release and other things as may seem expedient without being liable or responsible for any loss occasioned by any act or thing so done by them in good faith.
- (h) To acquire or otherwise to dispose off, mortgage, hire, lease or otherwise, movable or immovable, tangible and intangible properties and rights and benefits and to manage the same.
- (i) To receive, collect or realise or cause collection or realisation of all income that accrue or become due on all or any investments and to grant receipts and discharges.
- (j) To represent the Trust in all Courts (Original and Appellate) or before Judicial, Quasi Judicial Authorities and other Authorities, Departments of Government, Semi-Government or Local Authority.
- (k) To sign and verify all pleadings, memorandum of appeal, petitions and applications of all kinds, and to engage lawyers and other professionals and to take all such other necessary steps.
- (l) To borrow, or raise any money that may be required by the Trust upon such terms as may be deemed fit and to accrue any moneys so borrowed by mortgage of charge of all or any part of the assets belonging to the Trust.
- (m) To open and maintain accounts with Schedule Bank/s and authorise operation of such accounts jointly by two trustees one of whom shall be the managing trustee and to draw, accept, endorse, discount and/or negotiate any quasi-negotiable instruments on behalf of the Trust.

- (n) To enrol patrons, life members, members or in such other capacities as the Board of Trustees may deem fit and frame rules for the enrolment and other matters relating to such position.
- (o) To pay out of the Trust funds salaries, wages, rent, building maintenance, repairs and other expenses relating to the Trust, its administration, management of its activities or other affairs.
- (p) To appoint and/or dismiss staff, executives, officials, caretakers, attenders and other employees on such terms as Board of Trustees may think fit.
- (q) To appoint committees, sub-committees from among the members of the Board and/along with others and to assign duties and to frame such rules and regulations as the Board of Trustees shall think fit and to alter or vary the same from time to time, provided that such rules and regulations shall not be in consistent with the terms of these presents. The Board shall be entitled to frame, constitute and regulate any procedute of such committees.
- (r) To undertake and carry on any other works which may seem to the Board of Trustees capable of being conveniently carried on in connection with calculated directly or indirectly for the promotion of the objects of the Tust.
- (s) To decide all questions arising in the administration of Trust hereof and include all questions relating to the interpretation of these presents, the administration of any institution maintained by the Trust or concerning of anything or maintained by the Trust or matter relating to connected with or arising out of these presents or the operation thereof. The decision of the Board in all or any of the matters aforesaid shall be final.

- (t) To do all other acts, deeds, matters and thing which may be deemed necessary for carrying out the objects of this Trust or its administration.
- (u) The Board of Trustees shall conduct the activities of the Trust in accordance with the stipulations set out herein. The Board of Trustees may delegate all or anyof the powers vested in them to such person/s for such period as they may deem fit and may at any time revoke, alter, rescind such powers so delegated.
- (v) The Board of Trustees shall cause true and correct accounts to be kept of the sum/s of monies expended on behalf of the Trust and the accouts of the Trust shall be closed at such times as the Board may deem fit, but at least once in a year. The accounts shall be audited by a chartered accountant every year.
- (w) The powers enumerated in these present shall be exercried by the Board subject to their satisfying the conditions laid down under Section 11, 12, & 13 of the Income Tax Act, 1961, (43 of 1961) as amended from the time to time, so that the Income of the Trust will be exempt from the Income Tax for each and every assessment year.
- (x) The powers vested in the Board of Trustees shall be exercised according to the decision of majority of members of the Board of Trustees and by way of resolution passed either by circulation or at the meeting of the Board of Trustees.

6. CESSATION OF MEMBERSHIP

Any member of the Board of Trustees may resign such membership and such member shall cease to be a member only after the acceptance of his/her resignation.

7. BOARD OF TRUSTEES MEETINGS

Any member of the Board of Trustees may convene the meeting of the Board of Trustees by serving notice of the meeting in writing by ordinary post or by personal delivery on the other member of the Board and setting out therein the matter to be discussed, the place of meeting, the day, date and time of the meeting. The Board of Trustees shall meet from time to time as & when necessary, but at least four times a year to transact the business of the Trust and for consideration of the betterment of the Trust and its objections. The quorum for the meeting of the Board of Trustees shall be two. The Board shall cause the proceedings of its meetings recorded in a book.

8. FINANCIAL RESPONSIBILITIES OF THE TRUSTEES

The office of the Members of the Board of Trustees shall be honorary and a person holding such office shall not be entitled to draw any remuneration for carrying out his/her duties as Trustees, but shall be entitled to be paid his/her actual travelling expenses and other incidental expenses incurred by him/her for attending the meeting of the Board of Trustees or attending to work of the Trust. A member shall be entitled to the reimbursement of any expenses for the execution of the Trust and power of these presents.

9. ALTERATION OF RULES

No amendments to the Trust deed and rules and regulations shall be made which may prove to be repugnant to the provisions of section/s 2(15) 11, 12 and 13 and 80 - G of the Income Tax Act 1961. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.
